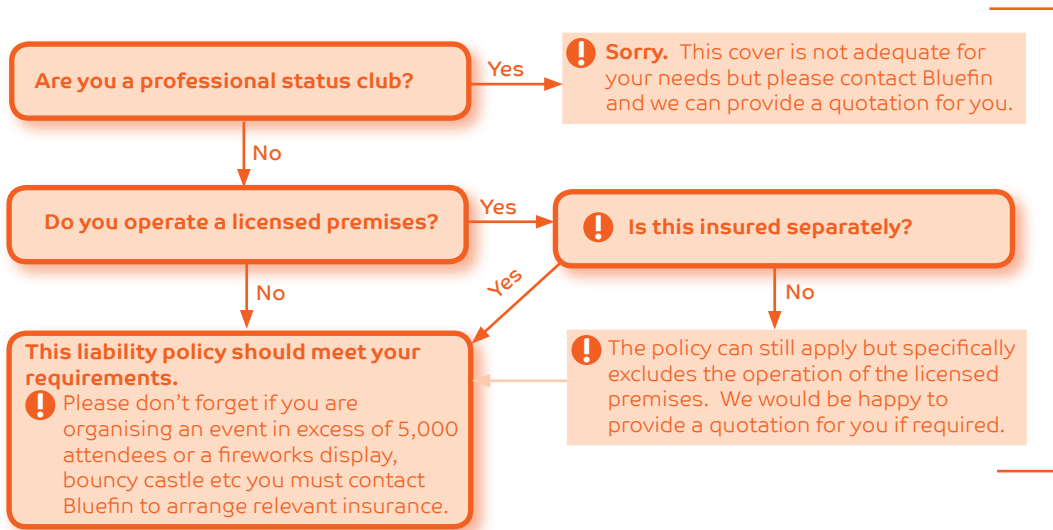
Claims (important information)
